About MSU's Legislative Leadership Program and the Michigan Health Policy Issues Group

MSU's Legislative Leadership Program invites new members of Michigan's House of Representatives and Michigan Senate to engage in interactive sessions with content experts, including university faculty and practitioners, in the brief time between election and their first legislative sessions.

At its 1994 inception, LLP was designed to create a forum and the resources to help newly elected legislators meet the challenges of serving in a state with term limits. The program was meant to help legislators forge links to university policy resources.

Since that time, LLP has evolved into a broadened opportunity to gain insights into concepts that affect statewide constituencies, into evidence-based information on emerging issues and into the art and science of governing in divided times, such as under state House co-speakerships.

At the same time, IPPSR has evolved as a hub for policy expertise, information and outreach, a center for survey research training and excellence and an opportunity for training for those who seek leadership through elected office or public service. The program is built upon a series of specially designed events, including presenters, researchers and facilitated discussions. Sessions are focused on topics of compelling interest, from the state's revenue stream, to its expenditures, K-12 education, demographics and innovations.

IPPSR is proud that LLP has hosted a majority of newly elected legislators from each party and draws support from the Legislature's highest officers. The program continues to build on MSU's long-standing tradition of providing leadership training to state and county officials, community leaders, and aspiring public officials.

The LLP is consistent with the policy and research education efforts conducted both on and off campus in of support state legislators, their staffs and their communities. It resides at IPPSR as companion to IPPSR's Public Policy and Education, the Michigan Political Leadership Program, the State of the State Survey and Office for Survey Research. LLP draws on the resources and leadership of each of these outstanding programs.

Emerging Issues: Health Policy

During 2018, health policy was identified as an emerging issue within the framework of IPPSR's educational offerings through the Legislative Leadership Program.

Additional focus was brought to Michigan health policymaking with the support of the Michigan Health Endowment Fund and MSU's Institute for Health Policy.

The Institute for Public Policy and Social Research builds problem-solving relationships among policymakers and researchers and applies best practices to issues facing the State of Michigan. IPPSR's unique mission combines public education and training programs with research on issues of public policy, survey research services and the initiation of public needs among diverse audiences. Programs include a focus on policy education and political leadership training.

Located within the College of Human Medicine, the Michigan State University Institute for Health Policy serves a unique role facilitating and supporting collaborative relationships among CHM faculty and researchers throughout campus. These collaborative activities inform policymakers, state agencies and others with a goal of improving health care delivery in Michigan.

This educational outreach allows IPPSR to meet its long-established educational missions bridging policy and practical applications of personal leadership, governing and economic growth. They also are in step with IPPSR's other enriching programs – including Public Policy Forums, Michigan Political Leadership Program, the Rosenthal Internship Awards, Office for Survey Research, State of the State Survey and the newest addition, the Michigan Policy Insiders Panel.

Dr. B. Keith English, M.D., is Professor and Chair of the Department of Pediatrics and Human Development in the College of Human Medicine at Michigan State University. He is a native of Texas, earned his B.A. in general science *summa cum laude* from Coe College in Cedar Rapids, Iowa, and his M.D. from Baylor College of Medicine in Houston, Texas, where he was elected to Alpha Omega Alpha.

He completed his pediatric residency and chief residency at Baylor College of Medicine/Texas Children's Hospital/Ben Taub General Hospital in Houston. He then trained in pediatric infectious diseases at the University of Washington/Seattle Children's Hospital, where he worked in the lab of Chris Wilson. English joined the faculty in the Department of Pediatrics at the University of Tennessee Health Science Center and Le Bonheur Children's Hospital in Memphis, TN, in 1990. He was appointed Chief of the Division of Pediatric Infectious Diseases at Le Bonheur in 1996 and was promoted to Professor of Pediatrics at UTHSC in 2000.

English played a leading role in helping the Memphis community respond to the 2009 H1N1 influenza A pandemic – he was honored for these efforts with the Tennessee chapter of the American Academy of Pediatrics' 2010 "Pediatrician of the Year" award. In 2013, he was recruited to the College of Human Medicine at Michigan State to Chair the Department of Pediatrics and Human Development. He is a member of the American Pediatric Society, the Society for Pediatric Research, the Infectious Diseases Society of America, and the Pediatric Infectious Diseases Society. He has been a member of the Pediatric Infectious Diseases sub-board of the American Board of Pediatrics since 2008, chaired that sub-board from 2012-14, and is now Medical Editor of the sub-board. His laboratory studied macrophage responses to bacteria and bacterial products, and he has authored 70 peer-reviewed publications.

His business practices are focused on continuous quality improvement, optimizing productivity, program development and implementation and consensus building.

Taylor is a native of Toledo, Ohio. He began his career at the Area Office on Aging of Northwestern Ohio where he was Director of Program Development and Quality Assurance. While there, he was recognized as one of Ebony magazine's *30 Leaders of the Future*.

At the Florida Department of Elder Affairs, Taylor was the Division Director, Statewide Community Based Services. He led a staff of 240 and was responsible for a \$330 million budget to administer the federal funding directed to programs of the Older Americans Act, including care management, caregiving, and senior employment and meal programs. Under his leadership, Florida's Nursing Home Diversion Program became a national model to transition individuals from institutional to community-based settings.

At the federal level, Taylor was an Aging Services Program Specialist for the U.S. Department of Health and Human Services – Administration for Community Living (ACL). From a regional office in Atlanta, Georgia, he was the liaison for eight different states – interpreting federal regulations, policies, guidelines and instructions for States, Area Agencies on Aging, and other organizations and institutions serving older persons, adults with disabilities, and their caregivers.

Ron Taylor was a 2005 Fellow in the Re-Balancing Long-Term Care Program of the Robert Woods Johnson Foundation and University of Minnesota.
