Opportunity #1: Addressing the Needs of Michigan's Working Poor

Problem: It is incredibly difficult for low-income families in Michigan to transition from state assistance to the workforce.

Solution: The proven approach to breaking the cycle of under-employment is Business Resource Networks. These local, small collaborations fund Success Coaches for high risk employees and provide.

- Workplace-based employee success coaching, addressing potential problems in advance.
- Real-time support services for childcare, healthcare, financial and time-management needs.
- Support for building key work behaviors in order to bypass the cliff effect.

Opportunity #2: Providing Career Pathways for Youth

Problem: Michigan has no systemic and consistent approach to helping youth identify career pathways that suit their interests and capabilities.

Solution: The solution lies in using what exists and has been proven effective, by scaling it to the level of need.

- Reboot the Youth Corps Mentorship Program.

Opportunity #3: Boosting Connections for Reemployment of UI Recipients

Problem: Unemployment Insurance (UI) recipients remain unemployed longer than necessary, even as businesses are desperate for people to hire.

Solution: After years of urging by Michigan Works! and its local boards, state officials are now undertaking the early steps in establishing a technological approach to making faster connections for re-employment.

- This is in the early stages of development and will require an ongoing, strong commitment.
- We are eager to ensure these efforts are accomplished in concert with Michigan Works! leaders.
- We'd like to ensure job seekers are getting access to the full array of training, development and support to which they are entitled.
