






Michigan Passenger Vehicle Exports to Canada






What's This? 

- Some U.S. manufacturers are seeing increased orders because of companies avoiding new tariffs.
- Tariffs, especially the 145% tax on Chinese imports, are boosting demand for some U.S.-made goods, benefiting smaller players.
- Some manufacturers dependent on imports have a less positive view of tariffs, owing to increased production costs.






Reduced Global Competitiveness Due to Higher Input Costs
